On the motion of Commissioner Strickland, which carried unanimously, the following Resolution was adopted:

**RESOLUTION OF THE GLYNN COUNTY BOARD OF COMMISSIONERS  
REGARDING TRAP-NEUTER-RETURN OF FERAL/COMMUNITY CATS**

**WHEREAS**, trapping, neutering, vaccinating, treating for injury or illness and returning ("TNR") feral/community cats to their habitats has been recognized by organizations such as the National Animal Control Association and the Humane Society of the United States as a cost effective method to reduce the number of feral/community cats present in a community; and

**WHEREAS**, the Glynn County Board of Commissioners recognizes that TNR is an alternative mechanism for controlling the feral/community cat population which has the potential to reduce the feral/community cat population while simultaneously reducing the necessity for euthanasia; and

**WHEREAS**, the potential benefits of resident-led TNR programs can be achieved without using additional taxpayer funds; and

**WHEREAS**, individual residents and private animal welfare organizations may wish to engage in TNR programs or offer financial assistance to TNR programs and/or otherwise facilitate such TNR programs;

**NOW THEREFORE, BE IT RESOLVED**, by the Glynn County Board of Commissioners, acting in its capacity as the governing authority for Glynn County, Georgia, that it be known that the Glynn County Board of Commissioners approves of and applauds individuals and/or organizations that organize TNR programs, provided that such TNR programs comply with federal, state, and local laws; and

**BE IT FURTHER RESOLVED**, that the County Administrator will provide a copy of this Resolution to any member of the community engaged in a TNR program or to any member of the public upon request.

This Resolution will be effective upon adoption.
